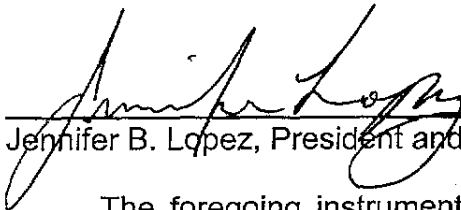
THE UNDERSIGNED, being the sole director and president of Big Bagel, Inc., does hereby amend its Articles of Incorporation as follows:
