The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

# ARTICLE ONE

NAME

The name of the corporation is DSD Group, Inc.

#### ARTICLE TWO

#### PRINCIPAL OFFICE
