Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is presently **CCM ADVISORS, INC.**

2. The following Amendment to the Articles of Incorporation was adopted by the Directors and Shareholders of the Corporation on November 15, 2004, in the manner prescribed by the Florida Business Corporation Act, and shall become effective on that same date.
