Pursuant to the provisions of §607.1003 and §607.1006 of the Florida Business Corporation Act (the "FBCA"), whOOdoo.com, Inc. (the "Corporation") adopts this Second Amendment to the Articles of Incorporation set forth below:

1. The name of the Corporation is WhOOdoo.com, Inc.
2. The Corporation's Articles of Incorporation were filed with the Florida Secretary of State on April 9, 1999.
3. The principal address of the Corporation is 1660 Trade Center Way, Naples, FL 34109.
