ARTICLES OF INCORPORATION

OF

OUORUM BROADCASTING OF ROCKFORD, INC.

The undersigned, an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is Quorum Broadcasting of Rockford, Inc.

SECOND: The street address, wherever located, of the principal office of the corporation is 18 Newbury Street. Boston, MA 02116

ADDRESS

To engage in any lawful business for which corporations maybe organized under the Florida Business Corporation Act.

EIGHTH: The duration of the corporation shall be perpetual.
