The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: THE LEVIATHAN GROUP, INC. The principal office of the Corporation is The mailing address of the Corporation is 200 E. Robinson Street, Suite 500, Orlando, Florida 32801.
- <u>Article 2. Duration</u>. The duration of the Corporation is perpetual.
- Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
