We are aware that Wright to Frame, Inc.'s registration with the State of Florida was deactivated due to our failure to file the above listed reports. For this we regret and offer no excuses.

We do offer the following as the reasons for these oversights. During the year 2002 our company had changed accounting personnel, either of which were depended on to complete our filing requirements. Then during the mid summer time frame we relocated the business from Largo to Orlando. In the meantime, the filing of our UBR for 2001 did not occur. I assure you, this was not intentional.


Further, and we are presuming that as a result of our move, and the address change, the forms for filing the UBR for 2002 did not reach us. It is my belief that this situation has been complicated by my having suffered serious head injuries from an automobile accident, from which I am still recovering.
