# ARTICLES OF INCORPORATION OF A & A BOOKKEEPING & TAX SERVICES, INC.

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I: NAME

The name of this corporation is A & A Bookkeeping & Tax Services, Inc., and the principal place of business shall be at 1455 S. Ferdon Blvd., Suite A-1, Crestview, Florida, 32539.

#### ARTICLE II: DURATION

The corporation shall exist perpetually.

#### ARTICLE III: PURPOSE

The purpose or purposes for which this corporation is organized is to engage in any activity or business permitted under the laws of the United States and the State of Florida. This shall be a general purpose corporation. Its goals and purposes shall be determined by its directors. The corporation may hire such employees as may be necessary or desirable to accomplish its purposes, and may hold such licenses as are necessary or convenient for corporate purposes. Additionally, the corporation shall be entitled to enter into contracts of every nature, to own real or personal property, to borrow money, and to do all other things necessary or convenient to corporate purposes, and to do all things authorized by the State of Florida.

The amount of capital stock authorized by the corporation shall be one hundred (1000) shares of common stock with a par value of one (\$1.00)

dollar per share. The whole or any part of the capital stock of this corporation shall be payable in cash, or in property, labor or services, at a just valuation to be fixed by the Board of Directors.

#### ARTICLE V: INITIAL CAPITAL

The amount of capital stock with which this corporation shall begin business shall not be less than one thousand Dollars (\$1,000.00).

#### ARTICLE VI: SHAREHOLDER'S RIGHTS

Except as otherwise provided by law, the entire voting power of the election of directors and for all other purposes, shall be vested exclusively in the holders of the outstanding common shares.

#### ARTICLE VII: PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as maybe done without issuance of fractional shares) at the price at which it is offered to others.

# ARTICLE VIII: INITIAL REGISTERED OFFICE

#### ARTICLE IX: INITIAL REGISTERED AGENT

# ARTICLE X: INITIAL DIRECTORS AND OFFICERS

#### ARTICLE XI: INCORPORATION
