ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Fiorida.

ARTICLE I

The name of the corporation is: IRON TRADING, INC..

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
