

**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, do hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is Tradewind Properties, Inc., and the address of the principal office and mailing address of the Corporation is 17105 San Carlos Blvd., Suite A6-189, Fort Myers Beach, Florida 33931.

ARTICLE II

Corporate Purpose

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III

Authorized Stock

The aggregate number of shares of the Corporation shall be 1,000, all of which are to be voting common stock having a par value of \$1.00 per share.

ARTICLE IV

Registered Office and Registered Agent

The street address of the initial registered office of the Corporation in the State of Florida shall be 17105 San Carlos Blvd., Suite A6-189, Fort Myers Beach, Florida 33931. The name of the initial registered agent of the Corporation at the registered office shall be Ronald Menard.

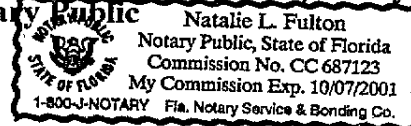


