In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles Of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The Name of the Corporation ("Corporation") is EDUCATIONAL THERAPY FOR ALL PEOPLE, INC.

ARTICLE II

The existence of the Corporation shall begin on the date the Corporation is deemed filed by the State Of Florida.

ARTICLE III

The street address of the principal office of the Corporation is 445 Bouchelle Drive, Suite 205, New Smyrna Beach, Florida 32169.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$.01 per share, all of which shall be Common Shares. 
