To whom it may concern:

My enclosed Business Report is late this year but for reasons and circumstances that I hope you will understand. In early April, I had a complete failure of my right knee. The early diagnosis was that it was a failure of the meniscus but it turned out to be a great deal more.

My orthopedic surgeon put me immediately on crutches and scheduled arthroscopic surgery for later in April. As you may know, "simple" arthroscopic surgery is a fairly routine medical procedure these days. As a matter of fact, mine was done "out-patient". I'd be back to normal in "just a few days".


But something went terribly wrong just a few days after my surgery. In less than 24 hours, I was diagnosed with a serious *E. Coli* bacterial infection in the original surgery site, went in the hospital for a second operation and my temperature went as high as 104. I was in the hospital, with three IV's going at the same time, for a week.

I still have a catheter stuck in my right arm and for the past 5 weeks, I have been getting IV antibiotics twice a day - an hour each morning and then again each evening. It has only been the last week that I have been allowed to leave home for any non-medical reasons- not that I've had the strength to even think about getting out of bed.

So, under the circumstances, I would hope that you will see fit to wave any late fees and/or penalties that might have automatically been added to our report fees.
