ARTICLES OF INCORPORATION
OF

ARTICLE I – NAME

The name of this corporation is SHANA DAHER ENTERPRISES, INC.

ARTICLE II – PRINCIPAL PLACE OF BUSINESS


ARTICLE IX – BY-LAWS
