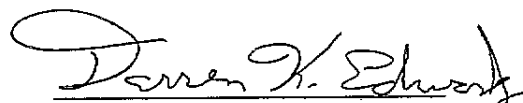
## DESIGNATION AND ACCEPTANCE OF REGISTERED AGENT
