Dear Madam or Sir:

We are writing on behalf of the above taxpayer regarding their 2000 Uniform Business Report (the Corporate Annual Report). The taxpayer just received a Notice indicating a fee due in the amount of \$550. The taxpayer acknowledges the Report is being filed after the original May 1, 2000 due date, but respectfully requests you accept the enclosed check for \$150 and remove the additional late filing penalty.

This is the taxpayer's first corporation. As such, they were not familiar with the Report. They did not know to look for the report among the volumes of other documents they received in the mail from IRS. The taxpayer knew from past experience that we use our own forms when preparing tax returns. We do not typically use the original forms that are mailed to our clients. Unfortunately, we did not request to see everything they had received. The taxpayer completely relied on us to ensure they were in compliance with all required filings. They sent us the enclosed report as soon as they received it. We then realized they had never paid the original fee...and they were wondering why we never prepared the Report in the first place. This was a completely unintentional oversight.

Please abate any late filing penalties. This was an unusual circumstance. We understand the need for the State to enforce compliance of their laws by means of a penalty provision. The fundamental reason for having penalties is to support and encourage voluntary compliance. Had the taxpayer been aware of the filing requirement, they most certainly would have timely filed the Report. Had we known they had their Report, we most certainly would have ensured it was timely filed.

The taxpayer greatly appreciates your consideration in this matter. Please allow them this one time misunderstanding. It won't happen again. We will no longer make any assumptions regarding a form one of our clients receives. We will automatically request they mail everything for us to review. In addition, we are implementing a yearly mailing in April to remind our corporate clients to file their Annual Reports. Further, this taxpayer now knows to look for the Annual Report. We apologize for any inconvenience this has caused.
