## ARTICLES OF INCORPORATION OF GREAT WESTERN UNDERWRITERS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be GREAT WESTERN UNDERWRITERS, INC.
