ARTICLE I. NAME

The name of this corporation is
FLORIDA PARADISE ENTERPRISES, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE IV. CAPITOL STOCK

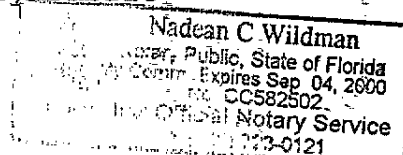
