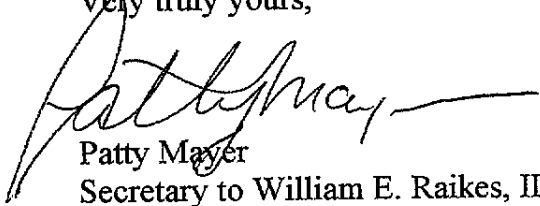

ARTICLE I

NAME

The name of this corporation is Systems Design and Technologies, Inc.

ARTICLE II

NATURE OF BUSINESS

manifesting their intention that a certain amendment of these Articles of Incorporation be made.

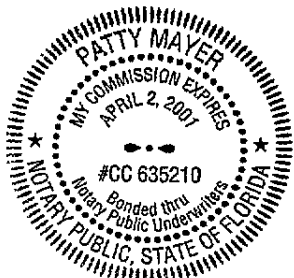

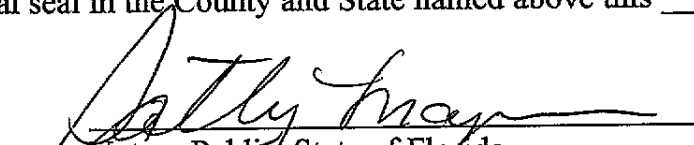

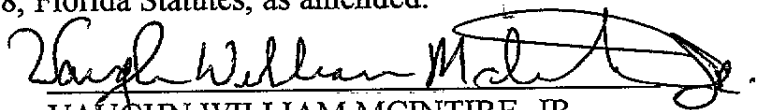
