ARTICLE I - NAME

The name of this Corporation is Sca Wood Design Co. Inc. The address of the principal office of this Corporation, shall be 3540 NW 10th Avenue, Fort Lauderdale, Florida 33309, and the mailing address of the Corporation shall be the same.

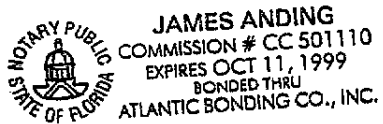


