NAME OF THE CORPORATION

The name of the corporation is Sun & Son Enterprises, Inc.

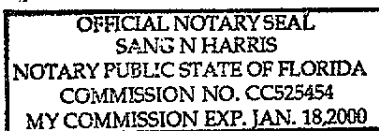
