The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Professional Corporation under the laws of the State of Florida.

ARTICLE I (NAME)

The name of the Professional Corporation shall be **BARBRA AMRON WEISBERG**, **P.A.**Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors or Stockholders.

ARTICLE II (PURPOSE)

When not prohibited by law, any action by the shareholders of this corporation which is within their power taken at a meeting of such shareholders shall be valid for all intents and purposes whether or not lawful notice of said meeting shall have been given to all shareholders, as required by law or the ByLaws of this corporation, if at any time prior to, during or subsequent to such meeting all shareholders shall execute a waiver of notice of such meeting in writing and providing a majority of the shareholders shall have approved or approve the action taken at such meeting.

When not prohibited by law, any action of the shareholders of this corporation may be taken without a meeting if consent in writing, setting forth the actions so taken, shall be signed by all the persons who would be entitled to vote upon such action at a meeting and filed with the Secretary
