**NAME**





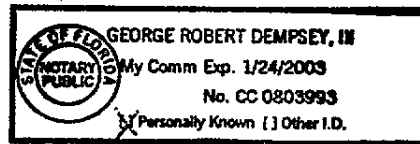
