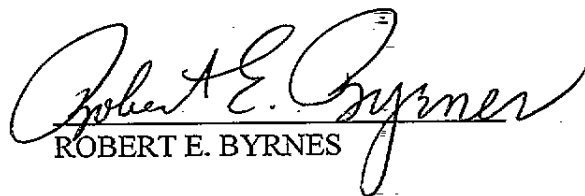
ARTICLE 8.

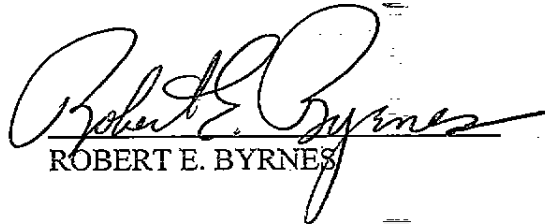
