**ARTICLE I - CORPORATE NAME**

**ARTICLE II - NATURE OF BUSINESS AND POWERS**

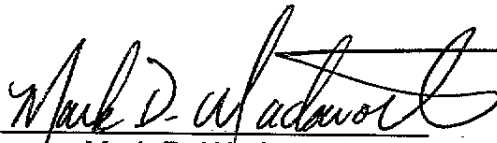
