**ARTICLES OF INCORPORATION
OF

ARTICLE I

Name

Initial Director

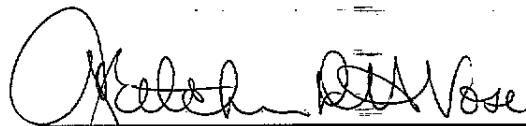
The corporation shall have one director who shall manage the corporation. The initial director shall be Dudley B. Hill.

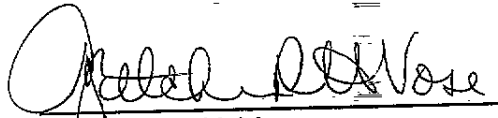
