

ARTICLES OF INCORPORATION OF TELECOM PARTNERS, INC.

The undersigned incorporators, being competent to contract, subscribe to these Articles of incorporation to form a corporation for profit under the laws of this State of Florida.

ARTICLE I - NAME

The name of this corporation shall be TELECOM PARTNERS, INC. The principal address of this corporation is 5900 S. Tamiami Trail, Suite H, Sarasota, Fl 34231.

ARTICLE II - BUSINESS AND ACTIVITIES

This corporation may, and is authorized to, engage in any business as permitted under the laws of the United States of America and the State of Florida.

The authorized capital stock of this corporation and the maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock having a par value of NONE per share.

ARTICLE VI - DIRECTORS

- A. The initial number of directors of this corporation shall be ONE (1).
- B. The number of directors of this corporation may be either increased or diminished from time to time by the board of directors or the shareholders in accordance with the bylaws of this corporation.
- C. Directors, as such, shall receive compensation for their services, if any, as may be set out by the board of directors at any annual or special meeting thereof. The board of directors may authorize and require the payment of reasonable expenses incurred by directors attending meetings of the board of directors.
- D. Nothing in this article shall be construed to preclude the directors from serving this corporation in any other capacity and receiving compensation therefrom.

In case one or more vacancies shall occur in the board of directors by reason of death, resignation, or otherwise, the vacancies shall be filled by the shareholders of this corporation at their next annual meeting or at a special meeting called for the purpose of filling such vacancies: provided, however, that any vacancy may be filled by the remaining directors unfil the shareholders have acted to fill the vacancy.
