

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
GRS NATIONAL SERVICES, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Florida profit corporation (the "Corporation") does hereby certify:

1. The name of the Corporation is GRS National Services, Inc., Document Number P99000034243.
2. In order to change the name of the Corporation, Article I of the Articles of Incorporation is hereby amended in its entirety, so that, as amended, Article I shall be and read as follows:

**ARTICLE I**

**NAME**

The name of this Corporation is generalRoofing National Services, Inc. (hereinafter called the "Corporation"). The address of the principal office and the mailing address of the Corporation is 3323 W. Commercial Blvd., Suite 200, Ft. Lauderdale, FL 33309.

3. This Amendment to the Articles of Incorporation of the Corporation shall be effective at the time of filing with the Secretary of State of the State of Florida.
4.
