ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF

The undersigned, as the President and Secretary of CALIFORNIA CUSTOM MOLD, INC., does hereby certify that the Amendment provided for herein was adopted by the stockholders and directors on the 17th day of May, 1999.

1. Amendment Adopted: Article I of the Articles of Incorporation is hereby amended to read as follows:

"ARTICLE I - Name and Address
