

ARTICLES OF INCORPORATION
OF

RJC CONSULTING COMPANY

ARTICLE I - NAME

The name of this corporation is RJC CONSULTING COMPANY.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE X - AMENDMENT

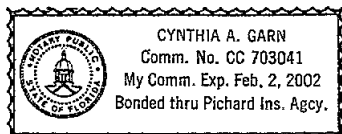


