Articles of Incorporation

OF ASIA AMERICAN MARINE FLORIDA, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I Name of Corporation

The name of this corporation shall be: Asia American Marine Florida, Inc.

ARTICLE II Nature of Business

The general nature of the business to be transacted by this corporation is any business permitted under the laws of the United States and the State of Florida.

ARTICLE III Capital Stock

The maximum number of shares the corporation is authorized to have outstanding at any one time is: 100,000 shares of One (\$1.00) Dollar par value all of which shall have the same rights and privileges.

ARTICLE IV Initial Capital

The amount of capital with which this corporation will begin business is not less than Five Hundred (\$500.00) Dollars.

ARTICLE V

<u>Term of Existence</u>

This corporation is to exist perpetually.

ARTICLE VI Principal Place of Business

The initial street address in this state of the principal office of this corporation is: 149 131st Avenue East, Madiera Beach, Florida 33708. ARTICLE IX Designation of Registered Agent
