ARTICLES OF INCORPORATION

SALANDE AM BISH

BEACHSIDE CONTRACTORS, INC.

Article I - Name

The name of this corporation is Beachside Contractors, Inc., and the corporations principal office and mailing address of the corporation shall be 532 Carriage Circle, Satellite Beach, FL 32937.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporation shall be April 5, 1999.

Article III - Purpose

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

Article IV - Capital Stock

This corporation is authorized to issue 1000 shares of \$1.00 par value common stock.

Article V - Preemptive Rights
