ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this corporation is LISA FRANK CUSTOM HOMES, INC. and is located at 553 Hawksbill Island, Satellite Beach, FL 32937.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

and shall inure to the benefit of the heirs, executors and administrators of such a person.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
