ARTICLES OF INCORPORATION OF ENETCLASSIFIEDS, INC.

The undersigned subscribers to these Articles of ARE ARE Incorporation, each a natural person competent to contract themselves together to form a corporation the laws of the State of Florida.

<u> ARTICLE I - NAME</u>

The name of this corporation is ENETCLASSIFIEDS, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of business to be transacted by this corporation shall be to manufacture, purchase, or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services, of every class, kind, and description; except that is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, fraternal benefit society, cooperative association, state fair or exposition. - 5. To make and enter into all contracts necessary and proper for the conduct of its business;
- 6. To purchase the corporate assets of any other corporation;
- 7. To take, hold, sell and convey such property as may be necessary in order to obtain or secure payment of any _____ indebtedness or liability to it;
- 8. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise dispose of the shares of the capital stock or any bonds or other evidences of indebtedness created by any other corporation of this State or any other State or Government; while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock;
- 9. To purchase, hold, sell and transfer shares of its own capital stock, but it can not purchase any of its own capital stock except from the surplus of its assets over its liabilities, including capital. Share of its own capital stock owned by the corporation shall not be voted directly or indirectly or counted as outstanding stock for the purpose of any stockholders' quorum or vote;
- 10.
