ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is CNC OF DAYTONA, INC.

ARTICLE II

The existence of the Corporation shall begin on April 16, 1999.

ARTICLE III

The street address of the principal office of the Corporation is 119 Barefoot Trail, Port Orange, Florida 32119.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ONE HUNDRED (100), par value \$.01 per share, all of which shall be Common Shares.
