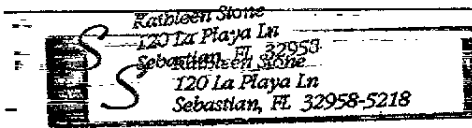

ARTICLE ONE-NAME

The name of the corporation is S & K Marine, Inc. *LOCATED @ 120 LAPLAYA LN, SEBASTIAN, FL 32958*

ARTICLE TWO-PURPOSE

This corporation is organized for the purpose of providing any legal service and goods permitted by the State of Florida.

ARTICLE THREE-CAPITAL STOCK

This corporation is authorized to issue one thousand shares of one dollar par value common stock, which shall be designated "Common Shares".


