Subject to the limitations contained in the By-Laws and any limitations set forth in Chapter 607, Florida Statues concerning corporate action that must be authorized or approved by the members of the Corporation, the By-Laws of this Corporation may be made, altered, rescinded, added to, or new By-Laws may be adopted, either by a resolution of the Board of Directors or by

following the procedures set forth in the By-Laws.

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of shareholders for their vote. Amendments may be adopted by a vote of two-thirds (2/3) of a quorum of shareholders of the Corporation.


