1. The following First Article of Amendment was adopted by unanimous vote of the shareholders:

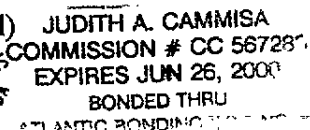
ARTICLE I: The name of the corporation is changed to **Angel Workshop, Inc.**

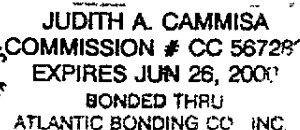
