ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator, and citizen of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of FLORIDA, pursuant to chapter 617, Florida Statutes, do hereby certify:

ARTICLE I

Name

The name of the Corporation shall be INNERQUEST, INC.

ARTICLE III

Purposes

Said corporation is an open-membership, non-profit, nondenominational, nonsectarian organization that advances prayer, meditation, contemplation, stress management and the lifestyles that supports them as a path for successful living. It honors the spiritual pursuits of all individuals, religions, denominations and sects. It does not evangelize or apostatize any belief system to the exception of another. Its primary mission is to serve people as a center for growth by providing facilities, resources and programs that aid the process of spirituality; spiritual awareness, growth and development. Said corporation is formed exclusively for educational and charitable purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

Manner of selection of directors:

The method of selection of directors by appointment shall be by the initial trustee as stated in the corporation bylaws.

ARTICLE VI

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida statutes unless limited are as follows:

No part of the assets, monies or net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation, the officers, board of directors or trustees shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
