## ARTICLES OF INCORPORATION

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is PALM BEACH HEARING CARE CENTERS, INC.

**SECOND:** The address, wherever located, of the principal office of the corporation, if known, is 2905G North Military Trail, West Palm Beach, Florida 33409.

**FOURTH:** The number of shares that the corporation is authorized to issue is two hundred, all of which are without par value and are of the same class and are to be Common shares.
