ARTICLE I

The name of this Corporation is Hallie L. Zobel, P.A. The nature of business of the professional association shall be the practice of law.

ARTICLE II

The Corporation may engage in any and all lawful businesses for which corporations may be incorporated under chapter 621, Florida Statutes. While pursuing its purposes, the Corporation may exercise the powers granted now or in the future by chapter 621, Florida Statutes, and by common law.

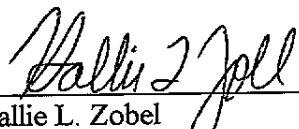

ARTICLE VIII

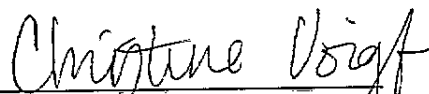
