ARTICLES OF INCORPORATION  
OF  
HRB ENTERPRISES INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is HRB ENTERPRISES INC. whose address is 630 Palm Dr., Satellite Beach, Florida 32937.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

The corporation may transact any and all lawful business for which corporations may incorporate under the Florida General Corporation Act.



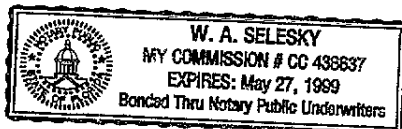


