As per telephone conversation with Ms. Mulligan--(10-19-2000), I am enclosing a completed form of the 2000 Uniform Business Report (UBR).

I was told by Ms. Mulligan to relate the circumstances why the "Dowel Tech International" Corporation was dissolved by the Florida Department of State effective September 22, 2000.

My attorney (Michael Swan) inappropriately submitted the address of the Dowel Tech International Corporation to be my home address. I was unaware of this at the time. When the 2000 corporation annual report was sent to me in or about January, it was immediately returned to the Florida Dept. of State because of the residential address--instead of the proper address of the place of business. Because of this I did not receive this annual report form.

I would greatly appreciate your consideration on this error by my attorney, and would appreciate your waiving the Reinstatement Fee that would normally be due, since I was not aware of this inappropriate filing by my attorney.

I am enclosing a check (as per Ms. Mulligan) in the amount of \$ 150.00 to reinstate the Dowel Tech International Corporation.

In addition I am completing the form sent by Ms. Mulligan, and am changing the name of the registered agent from Michael Swan to myself (Melvin D. Poveromo)

Thank you, and I would appreciate your consideration on this matter as well as your earliest convenience in responding since I cannot continue until I resolve this situation.
