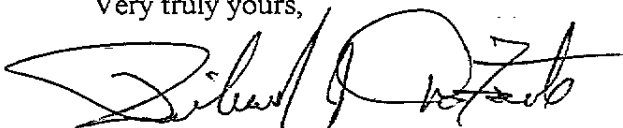

**ARTICLE I**

**Name**

1.1. The name of the corporation is **GULF BREEZE CLEANING SERVICE, INC.** and the corporation's business address is **8354 76th Avenue, Largo, FL 33777.**

**ARTICLE II**

**Duration**

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

**ARTICLE III**

**Purpose**

3.1 This corporation is organized for the purpose of transacting cleaning any and all lawful business.

**ARTICLE IV**

**Capital Stock**

4.1 This corporation is authorized to issue 7500 shares of stock of \$1.00 par value common stock.

### **Indemnification**

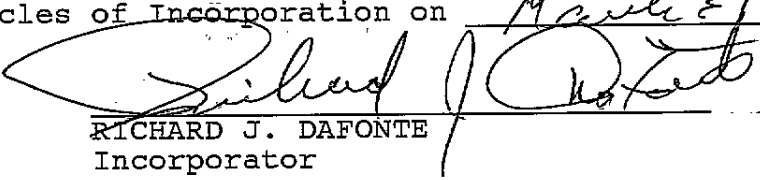

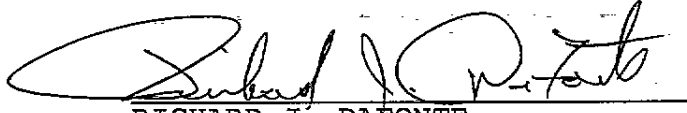

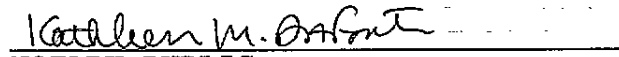
