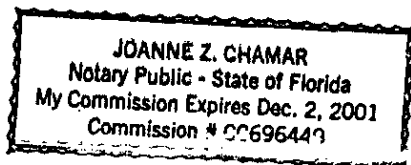
1. Dale D. Nice is the President of EXPERT SOLUTIONS FOR AVIATION, INC., a Florida corporation, (hereinafter "Corporation").
