# ARTICLES OF INCORPORATION

WILLIAM SAND, the undersigned, hereby associate CHECKERS OLD MUNICH ON THE BLVD., INC. for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do certify that CHECKERS OLD MUNICH ON THE BLVD., INC. has become such corporation under and pursuant to the following Articles of Incorporation.

# ARTICLE I

The name of this corporation shall be: CHECKERS OLD MUNICH ON THE BLVD., INC.

# ARTICLE II

The general nature of the business to be transacted and carried on by this corporation and its object and purpose is to transact any and all lawful business regardless of its nature or description.

### ARTICLE III

The maximum number of shares which this corporation shall be authorized to issue and have outstanding at one time shall be limited to One Hundred (100) shares of common stock, Ten Dollars (\$10.00) par value.

The consideration for the issuance of such shares of stock, or any part thereof, shall be money current of the United States of America, or property or services of value at least equivalent to the value of the stock to be issued, the same to be fixed and determined by the Board of Directors of this corporation at any meeting of the Board. Any and all shares of stock of this corporation shall be issued for the consideration, or for not less than the consideration fixed and determined as aforesaid, whether such consideration be cash, property or services, and any and all shares of this corporation's stock so issued shall be deemed fully paid and non-assessable.

The corporation shall begin business with paid in capital of not less than Five Hundred Dollars (\$500.00).
