ARTICLES OF INCORPORATION

OF

ARTICLE I NAME & PLACE OF BUSINESS

The name of the Corporation is **BZ International Corp.** The principal place of business and mailing address of the corporation shall be as follows: **2910 Woolridge Drive**, **Orlando**, **Florida 32837.**
