

The name of this corporation is CHALKER, INC.



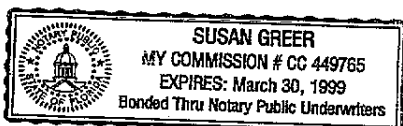

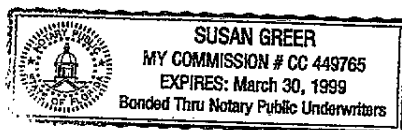
