**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE ONE**

The name of the corporation is: CASINO INVESTMENTS, INC.


