# ARTICLES OF INCORPORATION OF MEADE. PHOTOGRAPHY, INC.

### ARTICLE L NAME

The name of this corporation shall be: Meade. Photography, Inc.

## ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.

### ARTICLE III. PURPOSE

#### ARTICLE VI. TRANSFER RESTRICTIONS
