ARTICLES OF INCORPORATION

OF

NAILS BY CONSTANCE, INC.

ARTICLE I

The name of this Corporation shall be NAILS BY CONSTANCE, INC.

ARTICLE II

This Corporation shall exist in perpetuity.

ARTICLE III

The purpose for which the Corporation is organized is for the transaction of any and all lawful business for which Corporations may be incorporated under the Florida Corporation Act.

ARTICLE IV

The initial street address of the principal office of this Corporation in the State of Florida is: 3457 SW Pindo Palm Lane, Palm City, Florida 34990

ARTICLE V

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of One Dollar and No Cents (\$1.00) per share.

ARTICLE VI

These Articles of Incorporation may be amended in the manner prescribed by law. Every amendment shall be approved by the Board of Directors, proposed to them by the Stockholders and

The Corporation shall purchase term life insurance on each Stockholder of the Corporation.
